# **Background:**

The Police Exemplary Service Medal, administered by the Chancellery of Honours on behalf of the Governor General of Canada, recognizes Canadian police officers who have served in an exemplary manner, characterized by good conduct, industry and efficiency. Recipients must have completed 20 years of full-time service with one or more recognized Canadian police agencies including the LaSalle Police Service.

The silver Medal is circular with the Scales of Justice superimposed on a stylized maple leaf and circumscribed with "EXEMPLARY SERVICE". The Medal is suspended from a ribbon of five equal stripes - two gold and three blue. A Bar, bearing a stylized maple leaf, is awarded for each additional 10 year period of full-time police service.

# Kim Rathbone's Bio:

Kim is a married mother of two who started her career as a police officer over 20 years ago in the city of Windsor. She policed the City of Windsor for 15 years where she worked in various roles, which included patrol, court services and the bicycle unit. In 2009 Kim was afforded the opportunity to become a member of the provincial anti-violence unit, where she worked in a joint forces capacity with LaSalle Police and the former Amherstburg Police. Kim found her passion in 2011 when she became a member of the High School Resource unit. Building relationships and connections with local youth proved to be an incredibly fulfilling position for her. Realizing the importance and impact of adopting the community policing model was not only beneficial to her but the school communities in which she cared for. This revelation led Kim to accept an employment opportunity with a smaller Police service.

In 2015 Kim began another chapter in her career with Amherstburg Police, hoping to continue to build relationships within a smaller community. In Amherstburg, Kim began the Mental Health and Addiction officer position. While in this position she lead various initiatives such as employee wellness and peer support all the while assisting those in need within the community. Her drive and desire to serve her community to the best of her capabilities lead her to complete several courses through the University of Ohio and the University of Michigan.

In 2019 Kim's career started yet another chapter (the final chapter, she promises) when she was offered a position with the LaSalle Police Service. # **Brad Thornton's Bio:**

Brad Thornton is originally from Sault Ste. Marie, Ontario, but was raised in London, Ontario. He began his law enforcement career with the Ministry of Correctional Services in 1999 where he met his wife Jennie. In September 2000, Brad started his policing career with the Toronto Police Service and at the same time his wife Jennie accepted a position with the Ministry of Transportation in Windsor, Ontario.

On April 4th, 2001, Brad reunited with his wife after accepting a position with the LaSalle Police Service.

Brad and Jennie eventually moved to Amherstburg where they have raised their two children Karlee (18 years old) and Connor (16 years old).

Brad has been a part of several specialty units with the LaSalle Police Service; however, he mostly enjoys being a front line constable serving the citizens of LaSalle.

Lastly and most importantly, Brad is grateful to the Town of LaSalle for providing him with a rewarding and fulfilling career.

# Mauro Tonin's Bio:

Mauro was born raised in Windsor. His parents Cassiano and Yvonne Tonin along with his younger sister, Lisa Hearn have been very supportive throughout his life. In 1997 he met his wife, Mirella and was married in 2000. They have two sons, Luca 18 yrs and Adriano 15 yrs. Mirella, Luca and Adriano are a constant source of support inspiration.

Mauro graduated from Assumption High-school in 1995. Mauro then attended St. Clair College from September 1995 till April 1998 graduating with a diploma from the Law & Security Program.

Mauro enrolled at the University of Windsor - Criminology Program. During this time, he was hired with Revenue Canada - Customs and Excise Division.

Mauro began his policing career (his dream job) with the then Sandwich West Police Force on November 9<sup>th</sup>, 1990.

In January 5, 1993 Mauro was promoted to Constable with the LaSalle Police Service. During this time Mauro completed levels I and II from Dalhousie University and received certificates in Police Leadership and Management.

Mauro has been active in various programs within the Service. 1997 - present Mauro was appointed VIP officer for Prince Andrew. There he is known to all pupils and staff as "Constable Moe". He says that being involved with the VIP program is still the most rewarding aspect of policing. Even today he encounters some of the former students, now success adults, and they still refer to him as, "Constable Moe".

Mauro has served as the first full time Community Liaison Officer from (2004 - 2006). Mauro is also a Scenes of Crime Officer, Senior Child Seat Inspector, Historical Vehicle Committee Coordinator, Traffic Coordinator, Crime Prevention Through Environmental Design Officer, DNA samples - Officer, Major Case Team Member, Domestic Violence Investigator, RIDE Team Member, Co-chair of the LaSalle Police Youth Foundation Annual Charity Golf Tournament. In 2010 Mauro was a member of the 2010 Winter Olympics' Security Team -Whistler Theatre. Mauro was an original member of the Lasalle Police Bike Unit.

Mauro is the past founding member of both the B- Rad Program -VIP Program for grade 9's and Safe Seat Save Children Program. Assisted with the Greater Essex County District School Board - with Bully Prevention- A Peer Leadership Strategy Program.

Mauro has been named CAA Traffic safety officer of the year (2001) and under Mauro's guidance The School Safety Patrol Program was awarded, "CAA Central Ontario School Safety Patrol Achievement Award" (2003), beating out 40 other Safety Patrol Programs.

Mauro has received several Supervisors Commendations as well as numerous letters from community groups thanking him for his work.

Mauro continues to volunteer his personal and profession time within the LaSalle Community and City at various Service Events and as a charter member of the LaSalle Kin Club.

Mauro has been recognized for his contributions to the community by being 1 out of only 1500 officers nationwide to receive "Queen Elizabeth II Diamond Jubilee Medal, recognizing officers who have made significant civic contributions to their communities.

Mauro has also received "The Police Exemplary Service Medal" for having over 20 years of loyal and exemplary service to law enforcement in Canada.

2019 Mauro was promoted to the rank of Sergeant.

### Report LaSalle Police Service Board (June 21, 2021)

### **BACKGROUND INFORMATION:**

In December of 2019 Councilor Patricia Simone of Amherstburg invited several community service groups, sports organizations and churches (non-profits & charities) to the first Round Table Discussion Group held at the Libro Credit Union Centre in Amherstburg. This group was initiated with the goal of providing opportunity for our community groups to meet on a regular basis to discuss the needs of our Town and coordinate their efforts to meet those needs, discuss innovative approaches to challenges they face, share resources and network with other like-minded individuals. The number of groups in attendance has grown and new partnerships have formed, mutual support and networking have taken place. We have found this group forum especially helpful in the dark days of the pandemic when many groups have displayed optimism and innovation in their approach to community service. We have seen great benefits in the networking events, now done virtually. Needs have been identified and we have seen great unity and increased service delivery even through the pandemic. One of the greatest challenges our community groups face is to continue to recruit, train and support the many volunteers needed to continue to reach the people we serve. As you can imagine, in these days of pandemic, all services are done safely, one-on-one and social distanced, which requires more and more volunteers to do the important work of care and compassion, social engagement and offering support of various kinds. One of the many challenges we also face is the great financial impact of the pandemic on community service organizations. Organizations are experiencing reduced revenue from the lack of ability to do large scale fundraising events which has impacted their overall budget and cash flow. As well, we see individuals serving who may have experienced impact from lost income creating a challenge with fees and expenses associated with volunteering their time.

### **REQUEST:**

Many of the organizations participating in the ongoing conversations, the group we refer to as A.C.T. (Amherstburg Community Team) have put together request letters for your consideration which are attached to this report. It's our hope that the Police Service Board will consider waiving the fees associated with vulnerable sector criminal record checks. Each organization has expressed the difficulty they are experiencing in covering costs associated with the recruitment, training and deployment of their volunteers in these days.

Many of the insurance providers for the organizations represented here have clearly stated policy guidelines for vulnerable sector checks regarding how organizations must comply with the regulations in place to keep everyone safe. We have provided one newsletter as an example from Robertson Hall which is one of the larger insurance companies servicing the non-profit and charity sector. It is important to note that it is often the case volunteers who serve in multiple organizations must acquire multiple clearances at significant cost to the organizations or individual. Some of the volunteers also must go through the added expense of fingerprinting depending on their circumstance which adds to the cost.

Often times the costs of these clearances are borne by the volunteers themselves, especially in the case of newer organizations who have very limited funding. In the current environment, where more volunteers are needed to adequately meet the needs and serve in new and innovate ways, with more one-on-one interaction required to safely provide services, the fees associated with volunteering add one more barrier to recruitment and retention of volunteers. We must emphasize the tremendous reliance our organizations have on the volunteers who serve in various capacities; we simply can't do what we do without them. They are essential to the work.

### FINANCIAL IMPLICATION:

We are not unaware of the administrative costs associate with provision of vulnerable sector criminal record checks. We respect and deeply appreciate the countless hours of administrative work required to conduct the many request for these record checks. We also acknowledge that the funding model for local, municipal Police Service Boards may be very different from that of the provincially funded OPP Service. Many of our volunteers have difficulty understanding why, if they live in an area serviced by OPP, these clearances are provided free of charge compared to living in an area serviced by Municipal funded Police Service there are fees associated. We understand that there may be many reasons why the fees have been necessary in the past. We acknowledge all that our municipal Police Services do to provide excellent

service, care and support to our community and are extremely thankful for each and every public servant who plays a role in keeping our communities safe. Thank you.

We simply ask that you also consider some of the following as you consider our request to waive fees:

- a. The various community service organizations, sports clubs, and churches represented in this request provide valued services to our community and are currently experiencing unusual and difficult financial burdens due to the Covid19 Pandemic
- b. It is increasingly difficult to maintain a healthy, engaged, positive volunteer force and the more barriers we can remove from our valued volunteers, the better we can serve and meet the needs of the community.
- c. Many of the programs and services, ministry and support groups provided by the non-profit, charitable and sports organizations represented in this request are extremely beneficial and a vital part in sustaining healthy, thriving and optimistic communities.

### **RECOMMENDATION:**

At this time, we would recommend

- that the Police Service Board undertake a review of the fees associated with providing vulnerable sector criminal record checks to volunteers offering their services to registered non-profit groups and charities
- and further that if at all possible these fees be waived for volunteers of those groups
- and further that they communicate the result of their review and decision regarding the request in a timely fashion to the undersigned



If police clearance fees would be waived, it would lessen the financial burden on non-profit organizations and likely increase the number of volunteers we have to available to us.


