

**Subject:** Retroactive Appointment of Officers

#### **Background:**

Section 85 of the *Community Safety and Policing Act, 2019* introduces a requirement of Police Boards to appoint police officers prior to their swearing-in. This change went unnoticed by a number of police services until recently. #### **Background:**

Section 19 of the *Community Safety and Policing Act* (CSPA) permits the Chief of Police to request temporary assistance from another police service. Section 19(5) establishes a reporting requirement to the Inspectorate of Policing when this request is made.

On December 14, 2024, the Ontario Provincial Police requested temporary assistance from the LaSalle Police Service to provide an Intoxilyzer Technician to assist with an impaired driving investigation. We provided assistance.

On December 16, 2024, the LaSalle Police Service requested assistance from the Ontario Provincial Police (OPP) in the form of a digital forensic analyst to assist with a drug trafficking investigation. The OPP is aiding with our request.

On December 18, 2024, the Windsor Police Service requested temporary assistance from the LaSalle Police Service to provide an Intoxilyzer Technician to assist with an impaired driving investigation. We provided assistance.

On December 27, 2024, the LaSalle Police Service requested temporary assistance from the Strathroy-Caradoc Police Service to perform a digital forensic examination of three cells phones and two iPads. The SCPS is aiding with our request.

#### **Background:**

Ontario Regulation 393/23 requires front line officers have access to specific equipment in the event of active attacker situations.

LaSalle Police Service (LPS) has 9 front line cruisers. I have purchased 9 bolt cutters, 9 pry bars, and 9 sledgehammers so each cruiser has one of each.

Purchases were made at Canadian Tire stores to take advantage of Boxing Week sales but also to leverage additional costs savings via Canadian Tire rewards program. During Boxing Week, Canadian Tire offered 60X rewards for Canadian Tire credit card holders on purchases over \$200.

Using my personal credit card, I purchased 9 pry bars, 7 bolt cutters, and 7 sledgehammers for \$1,380. The accumulated Canadian Tire money from these purchases was \$298.26 that was used to redeem for 2 bolt cutters and 2 sledgehammers at a cost of \$293.76. This resulted in a \$4.50 surplus of Canadian Tire money in my account. I have repaid that amount in cash to LPS to ensure I did not benefit from these transactions.

I would not normally report a minor purchase to the Board but given that my personal credit card was used to save LPS money via reward points, I want to be transparent about the transactions and demonstrate that I did not receive any benefit. Receipts are attached.
