Purpose & Effect of Application: The property is designated 'Residential District' in the Official Plan and zoned 'Residential One (R1-h)' and Mixed-Use Two (MU2-h), according to Zoning By-law 8600, as amended.

The applicant wishes to sever three parcels of land, each with a frontage of approximately 8.7 metres and a depth of approximately 35.6 metres, having an area of approximately 310 m², and a fourth parcel of land with a frontage of approximately 38.7 metres and a varied depth, having an area of approximately 260 m². The retained parcel of land will have a frontage of approximately 8 metres and a depth of approximately 38.5 metres, having an area of approximately 1,191 m².

Should this application be approved, the applicant wishes to create 5 lots fronting on Stanton Avenue for four semi-detached dwelling units and one 3-storey, six-unit apartment building.
