Now until August 12, 2026	Changes to Voter Information (Elections Ontario)	Planning to vote? Confirm, update, or add your information with Elections Ontario at www.registertovoteon.ca or call 1-866-242-3025.
Friday, May 1, 2026	Nomination Period Begins	Candidates may begin filing nomination forms starting Friday, May 1, 2026, and may continue to file on any business day thereafter until Nomination Day (Monday to Friday, 8:30 am to 4:30 pm). On Nomination Day, Friday, August 21, 2026, nomination forms may be submitted between 9:00 am and 2:00 pm. s.33(4)
	Campaign Period Begins	The campaign period begins when a candidate files their nomination form and ends on December 31, 2026. Alternative time periods apply if the candidate withdraws their nomination, the Clerk rejects the nomination, or the candidate extends their campaign to eliminate a deficit. s.88.24(1), (2)
	Third Party Advertiser Registration Period Begins	Individuals, corporations, or trade unions may file the prescribed form with the Clerk to become a registered third-party advertiser. Restrictions apply regarding who is eligible to register. s.88.6(7)
August 14, 2026	Preliminary List of Electors	Elections Ontario to deliver the Preliminary List of Electors to the Town.
Friday, August 21, 2026, at 2:00 pm	Nomination Day (Nomination Period Ends)	<p>The last day to file a nomination. On this date, nomination forms may only be submitted between the hours of 9:00 am and 2:00 pm. s.33(4)(b)</p> <p>The last day for a candidate to withdraw their nomination is by filing a written notice with the Clerk no later than 2:00 pm. s.36</p>

Monday, August 24, 2026	Nominations Certified (Finalized List of Candidates)	<p>The Clerk shall examine all filed nomination forms prior to 4:00 pm and if satisfied, certify the nominations. s.35(1), (2)</p> <p>By 4:00 pm, the Clerk shall also declare any candidate(s) elected by acclamation. s.37(1)</p>
Tuesday, September 1, 2026	Voters' List Revisions to the Voters' List	<p>The Clerk shall make the Voters' List available to eligible individuals upon written request. s.23(2), (3), (4)</p> <p>Individuals may apply at the LaSalle Civic Centre, 5950 Malden Road, or online at www.lasalle.ca/election until the close of voting on October 26, 2026, to have their name added to or removed from the Voters' List, or to update their information. Requests may also be made to remove the name of a deceased person. s.24, 25</p>
Friday, October 16, 2026	Advance Voting Opens	<p>Online voting to open at 10:00 am. Electors can vote 24 hours a day once voting opens until October 26, 2026 at 8:00 pm.</p> <p>The Voter Help Centre will be open during this period to provide assistance and access to computers. Location and hours will be posted before the opening of the Voting Period.</p>
Friday, October 23, 2026	Close of Third Party Advertiser Registration Period	<p>Last day for a third party advertiser to file a notice of registration or withdraw their registration, during office hours (8:30 am to 4:30 pm). s.88.6(7), s.88.6(15)</p>
Monday, October 26, 2026	Voting Day	<p>This is the final day to vote. Electors can vote until 8:00 pm.</p> <p>The Voter Help Centre will be open from 10:00 am to 8:00 pm at the LaSalle Civic Centre, 5950 Malden Road.</p>

As soon as possible after Voting Day	Declaration of Results	As soon as possible, the Clerk shall declare the results and advise the public. s.55(4), (4.1)
Sunday, November 15, 2026	New Term of Office Commences	Elected members must take the oath of office before assuming their seat.
Tuesday, November 17, 2026	Inaugural Meeting of Council	The inaugural meeting of Council will be held on November 17, 2026.
Thursday, December 31, 2026	Campaign Period Ends	Last Day for candidates and registered third party advertisers to provide written notice of a deficit and the continuation of their campaign period. s.88.24(2), (4), s.88.28(2), (2.1)
Tuesday, March 30, 2027	Filing Date	By 2:00 pm, last day for candidates and registered third party advertisers to file initial financial statements and auditor's reports. s.88.30(1)
