RE: Broderick Road – Road Rehabilitation

Dear Resident,

The Town of LaSalle is writing to inform you of the upcoming construction project in your area that will involve the rehabilitation of Broderick Road. The project will begin in the summer of 2025 and is expected to be completed within a month. This notice serves to provide you with early awareness of the work that will be carried out and its potential impacts to the surrounding area.

Project Overview:

The Town of LaSalle will be using the **Cold In-Place Recycling with Expanded Asphalt Mix (CIREAM)** method to rehabilitate the roadway. CIREAM is a sustainable technique that involves milling and reusing the existing asphalt material, which is then treated with a recycling agent to restore the road's structural integrity. This method minimizes the environmental impact and reduces construction waste, while providing a long-lasting solution for road repair.

- There will be temporary road surface roughness as the CIREAM method is performed, but the final result will provide a smooth and durable surface.
