Background:

Please find attached "Police 4th Quarter Financial Report 2023" provided by Gaetano Ferraro, Manager of Finance & Deputy Treasurer with the Town of LaSalle. These reports have been requested on a quarterly basis.

The Police 4th Quarter Financial Reports indicate a final budget deficit of \$245,235. Although savings were realized in some areas, many non-discretionary expense accounts resulted in deficits as follows:

- ➤ \$12,506 reduction in Miscellaneous Revenue (fewer Police Clearances processed)
- > \$81,840 in additional wages (including regular pay, overtime, and specialty pay)
- > \$43,192 in additional CPP contributions
- > \$42,068 in additional OMERS contributions
- \$12,877 in additional WSIB premiums
- > \$16,010 in additional Green Shield premiums
- \$8,442 in additional telephone expenses
- \$58,049 in additional IT expenses (contracts & support)
- > \$9,837 in additional vehicle and equipment expenses
- \$11,091 in additional Criminal Investigation expenses
- \$6,612 in additional Court Services costs (including Court Security overtime)

Overall Summary

As of December 31, 2023 the LaSalle Police Service financial operations are consistent with a minor variance of under 3% of the approved budget..

Grants

As of the end of the fourth quarter, grants were consistent with budget and \$20,000 higher the prior year.

Other Revenue

Dispatch revenue has been recognized quarterly and consistent with the budget and the prior year. Miscellaneous revenue is below budget and consistent with the prior year. Youth Foundation revenue exceeded budget however are offset corresponding Youth Foundation expenditures.

Wages and Benefits

Wages and benefits are less than 2% above 2023 budget and slightly higher than prior year level.

Administrative Expenses

Administrative expenses are \$67,000 or 32% over budgeted amounts primarily as a result of information technology expenditures. Other administrative expenses such as office supplies, equipment, and communications are consistent with budget. Overall administrative expenses are slightly below the prior year.

Personnel Expenses

Personnel expenses were \$7000 or 5% below budgeted amount. Personnel equipment and memberships were under budget, offset by higher than budgeted amounts related to training and uniform expenses.

Facility Expenses

The budget relating to facility expenses has been transferred to the corporate facility department, consistent with other town facilities. The remaining facility budget relates to the dispatch main tower.

Vehicle/Equipment Expenses

Vehicle expenses were 5% or \$9900 above the budgeted amount. While fuel expenses were below budget, this was offset by higher than budgeted maintenance and lease costs. Overall vehicle/equipment expenses were \$22,000 below the prior year.

Program Services Expenses

Overall program services expenditures are \$52,000 over budget, this primarily consists of Youth Foundation expenses which were offset by matching revenue. In addition, criminal investigations and courts services costs were above budgeted amounts while other costs were fairly consistent with budget.

Transfer to Own Funds

The Transfer to Own Funds took place in the third quarter. This transfer will fund the Police Reserve, which in turn will fund the purchase of capital items consistent with capital planning. This process is consistent with the approach taken by the Town of LaSalle capital expenditures.
