Subject: Use of Board Resources for Election Purposes Policy

#### **Recommendation:**

That the report from the Board Secretary dated March 11, 2022 regarding Use of Board Resources for Election Purposes Policy be received and that the Board adopt the Town of LaSalle's *Use of Corporate Resources for Election Purposes Policy*, policy number G-EL-001, for the LaSalle Police Services Board during municipal election campaign periods.

# **Background:**

The *Municipal Elections Act, 1996* requires municipalities and local boards to establish rules and procedures with respect to the use of municipal or board resources, as the case may be, during an election campaign period, by May 1st in the year of a regular election.

Subsection 1(1) of the *Municipal Affairs Act* provides the following definition of the term "local board":

"local board: means a school board, municipal service board, transportation commission, public library board, board of health, police services board, planning board, or any other board, commission, committee, body or local authority established or exercising any power or authority under any general or special Act with respect to any of the affairs or purposes, including school purposes, of a municipality or of two or more municipalities or parts thereof"

As the LaSalle Police Services Board is subject to the *Municipal Elections Act*, 1996 and encompassed by the definition of "local board" in the *Municipal Affairs Act*, it is required to establish rules and procedures with respect to the use of board resources by May 1st.

The Corporation of the Town of LaSalle has a *Use of Corporate Resources for Election Purposes Policy* in place, Policy Number G-EL-001, that applies to all municipal and school board election candidates, including Mayor and Members of Council. Should the Board approve that the Town of LaSalle's Policy apply to its resources, those Councillors and staff serving on the LaSalle Police Services Board would follow the Policy as it relates to their resources, assets, and funding that are used.

The Board has the option of producing its own separate policy for the use of board resources during a municipal election campaign period. However, given the comprehensiveness of the Town of LaSalle's policy and the timing, it is recommended that the Board adopt a motion that the Town of LaSalle's Use of Corporate Resources for Election Purposes Policy applies to the LaSalle Police Services Board for municipal election periods.

By adopting the Policy, it is understood that references made therein to "Members of Council", "staff", "corporate resources, assets, and funding", apply to Board staff, resources, and funding.

# **Use of Corporate Resources for Election Purposes Policy**

Policy Manual Section: Governance - Election

Policy Number: G-EL-001 Authority: 9093/10, 04/14 Date Approved: March 9, 2010

**Department Responsible**: Council Services

Revision Dates: January 14, 2014, October 10, 2017, March 5, 2019

Status: Active

#### Purpose:

The purpose of this Policy is to clarify that all candidates, including Members of Council are required to follow the provisions of the *Municipal Elections Act, 1996* and that:

- No candidate shall use the facilities, equipment, supplies, services, staff or other resources of the Town for any election campaign or campaign related activities
- No candidate shall undertake campaign-related activities on municipal property
- No candidate shall use the services of persons during hours in which those persons receive any compensation from the Town

#### **Policy Statement:**

The *Municipal Elections Act, 1996*, establishes the election campaign finance rules for candidates running in a municipal election. Public funds are not to be used for any election related purposes, including the promotion of, or opposition to, the candidacy of a person for elected office. The *Municipal Elections Act* also sets out rules relating to campaign finance and prohibits the municipality from making contributions to a candidate in any form, which includes its assets, resources, and employees.

#### Scope:

This policy applies to all municipal and school board election candidates, including the Mayor and Members of Council.

#### Policy:

That in accordance with the provisions of the Municipal Elections Act, 1996:



- a. Corporate resources, assets and funding shall not be used for any election-related purposes: Resources, assets and funding include but are not limited to:
  - Telephone, Voicemail
  - Computer/laptop/tablet
  - Printer
  - E-mail, Town e-mail address
  - Scanner
  - Cell Phone
  - Fax Machine
  - Copier
  - Consumables related to the above equipment such as paper, toner etc.
  - Town Logo, Crest, Slogan etc.
  - Town Website and/or any Town social media platforms
- b. Staff shall not canvass or actively work in support of a municipal candidate or third party during normal working hours unless they are on a leave of absence without pay, lieu time, float day or vacation leave.
- c. Use of municipally-owned facilities is prohibited for any election-related purpose, which includes meet the candidates' night, parties and other expressions of appreciation, displaying of any campaign related signs in the window or on the premises, as well as displaying any election-related material in any Town property\*.

Clerk's Note: Where Town or municipal property is referred to, it includes the building and property on which it is located.

- d. Members of Council shall not:
  - print or distribute any material paid by municipal funds that illustrate that a Member of Council or any other individual is registered in any election or where they will be running for office;
  - ii. profile (name or photograph), or make reference to, in any material paid by municipal funds, any individual who is registered as a candidate in any election;
  - iii. print or distribute any material using municipal funds that makes reference to, or contains the names or photographs, or identifies registered



candidates for municipal elections; and that minutes of municipal Council and Committee meetings be exempt for this policy;

- iv. use web sites or domain names that are funded by the Town and shall not include any election-related campaign material;
- v. use the municipality's voice mail system to record election related messages; and shall use the Town's network (including the Town's email system) to distribute election related correspondence.
- vi. use photographs produced for and owned by the Town of LaSalle for any election purposes.
  - use photos taken utilizing Town cameras or sent through Town e-mail accounts
  - use the Town's social media platforms (Facebook, Twitter, Instagram) to advertise or otherwise promote their candidacy
  - wear clothing or display signs, stickers, markings on vehicles that advertise their candidacy while on municipal property
- vii. shall not post or comment on the Town's social media pages, and may not link their personal and/or election/candidate pages to the Town's social media pages and/or website

The above prohibitions also apply to an acclaimed Member or a Member not seeking re-election.

#### Limitation

Nothing in this policy shall preclude a Member of Council from performing their job as a Councillor, Mayor or Deputy Mayor, nor inhibit them from representing the interests of the constituents who elected them.

#### Implementation

This policy shall become effective immediately upon approval by Council.

Rationale and Legislative Authority



It is necessary to establish guidelines on the appropriate use of corporate resources during an election period to protect the interests of both Members of Council and the Corporation of the Town of LaSalle. The *Municipal Elections Act, 1996* prohibits a municipality from making a contribution to a candidate. The Act also prohibits a candidate or someone acting on the candidate's behalf, from accepting a contribution from a person who is not entitled to make a contribution.

As a contribution may take the form of money, goods or services, any use by a Member of Council of the Corporation's resources for his or her election campaign would be viewed as a contribution by the municipality to the Member, which is a violation of the *Municipal Elections Act, 1996* 

#### **Responsibilities:**

In accordance with the *Municipal Elections Act*, 1996 the Clerk be authorized and directed to take the necessary action to give effect to this policy. The Clerk is responsible for overseeing this Policy.

#### **Policy Review**

This policy will be periodically reviewed and updated as required. This policy must be reviewed by the stated review date and approved by the responsible department.

This resolution should also be sent to other Municipalities throughout Ontario for their endorsement consideration; and

That the request also be referred to the Sarnia Police Services Board and be presented via AMO delegations for endorsement consideration.

#### **BACKGROUND**

Council for the City of Sarnia has passed a resolution on December 13, 2021, requesting the Federal and Provincial governments consider making meaningful improvements to the release of offenders. The so-called "Catch and Release Justice" refers to the release of offenders by the courts whereby the offender is re-arrested by police for breaches of the release conditions.

The resolution indicates this approach has a negative impact on police workload, officer morale, and potentially law-abiding citizens.

Locally, council has asked that the matter be discussed at the Police Service Board level and that "a review of "catch and release justice" in the City of Stratford be referred to the Stratford Police Services Board to outline current challenges."

Further, council is requesting a resolution with recommended changes be brought back to council for January 24, 2022.

#### **ANALYSIS**

On its surface "Catch and Release Justice" is a reference to the increase in offenders being released after being arrested. This term mostly refers to release by the courts although police officers (Officer in Charge) have release authorities similar to that of the court.

In response to the request of council, a review of charges laid for these instances was completed. Approximately 60 more charges were laid in 2021 in comparison to the average of charges from 2018 to 2020. In reviewing the data this increase would represent an approximate 43% increase

in breach of release condition charges being laid by members of the service. I would caution that the data, while it does show an increase from 2018-2021, could also be indicative of the COVID pandemic whereby the courts (and police) were actively exploring opportunities to keep offenders out of custody, where possible. The result was that more offenders were released on conditions where re-offending in the community could have occurred. Likewise, the stressful nature of the pandemic should not be discounted as a contributing factor on this data.

#### RECOMMENDATIONS/COMMENTS

- The Stratford Police Service has experienced an increase in repeat offenders being released into the community only to re-offend.
- The impact of the pandemic on the police, justice and corrections system has been challenging to navigate
- More and more offenders are being released into the community on judicial release conditions that are continually breached leading to more arrests, charges, and court appearances.
- The community is frustrated with the lack of accountability on offenders and feel that their safety is being jeopardized.
- Police officers are resorting to "Officer in Charge" releases when offenders should be going to the courts for judicial releases because of workload.
- The court dockets will most likely be cleared of low-level offences resulting in no accountability for offenders
- Victims are feeling re-victimized by the system and losing faith/trust in the system.

For Council consideration:

That that City of Stratford endorse the Sarnia Catch and Release Justice resolution and add the following:

- The Federal and Provincial Governments recognize the linkage between mental health, addiction, homelessness, and crime.
- That all levels of government acknowledge that catch and release justice contributes to feelings of vulnerability within our communities and increases the cost of policing, social services, and health care in our communities.
- That all levels of government provide continued financial support to enhance funding in communities for Mobile Crisis Rapid Response Teams, Overdose Response Teams, Community Outreach Teams, Emergency Shelter facilities, Education and Awareness Programs, diversion programs, etc. under the umbrella of Community Safety and Well Being.
- That the Federal and Provincial Governments re-imagine a direct accountability framework specific to charges relating to failure to comply with release conditions.
- That consideration be given to provided holistic support to chronic re-offenders experiencing mental health, addiction, and homelessness issues with a multi-disciplinary team under one roof

  - c/ the number of times each of the following provisions was relied upon to not advise the individual of his/her right that he/she is "not required to provide identifying information to the officer" and/or the reason "why the police officer is attempting to collect identifying information about the individual":
    - i/ might compromise the safety of an individual (subsection 6(2)),
    - ii/ would likely compromise an ongoing police investigation (clause 6(3)(a)),
    - iii/ might allow a confidential informant to be identified (clause 6(3)(b)), and
    - iv/ might disclose the identity of a person contrary to law, including the YCJA (clause 6(3)(c));
  - d/ the number of times an individual was not given a receipt/document because the individual did not indicate that they wanted it;
  - e/ the number of times each of the following clauses were relied upon to not offer or give a receipt/document:
    - i/ might compromise the safety of an individual (subsection 7(2)(a)) and,
    - ii/ might delay the officer from responding to another matter that should be responded to immediately (clause 7(2)(b));
  - the number of attempted collections from individuals who are perceived, by a police officer, to be within the following groups based on the sex of the individual:
    - i/ male individuals, and
    - ii/ female individuals;
  - g/ for each age group established by the Chief of Police, the number of attempted collections from individuals who are perceived, by a police officer, to be within that age group;

- the number of times, if any, members of the police force were permitted to access identifying information to which access must be restricted by virtue of one or more of the following:
  - i/ for the purpose of an ongoing police investigation,
  - ii/ in connection with legal proceedings or anticipated legal proceedings,
  - for the purpose of dealing with a complaint under Part V of the *Act* or for the purpose of an investigation or inquiry under clause 25 (1) (a) of the *Act*,
  - iv/ in order to prepare the *annual report* or a report required due to disproportionate collection (under section 15 of the Regulation),
  - v/ for the purpose of complying with a legal requirement, or




