

## **The Corporation of the Town of LaSalle**

### **By-law Number 2025-055**

A By-law to establish an Administrative Monetary Penalty System  
in the Town of LaSalle

**Whereas** sections 8, 9, and 11 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended (the “*Municipal Act*”) authorize the Corporation of the Town of LaSalle to pass by-laws necessary or desirable for municipal purposes;

**And whereas** section 102.1 of the *Municipal Act* and *Ontario Regulation 333/07* (the “*Regulation*”) authorizes a municipality to require a Person to pay an Administrative Penalty if the municipality is satisfied that the Person has failed to comply with any by-laws respecting the parking standing, or stopping of vehicles.

**And whereas** section 434.1 of the *Municipal Act*, authorizes a municipality to require a Person, subject to conditions as the municipality considers appropriate, to pay an Administrative Penalty if the municipality is satisfied that the Person has failed to comply with a By-law of the municipality passed under the *Municipal Act*;

**And whereas** the *Regulation* authorizes a municipality to impose fees or charges in connection with the administration of an Administrative Monetary Penalty System;

**And whereas** the Council of the Town of LaSalle considers it desirable to implement an Administrative Monetary Penalty System as a means of encouraging compliance and enforcing its Designated By-laws, that those By-laws form part of this By-law as set out in Schedule “A” of Appendix “A” along with the respective penalties and short form wording as set out in the remaining Schedules attached to Appendix “A”;

**And whereas** the Council of the Town of LaSalle considers it desirable to enforce and seek compliance with the designated By-laws, or portions thereof, through an Administrative Monetary Penalty System;

**Now therefore the Council of the Corporation of the Town of LaSalle hereby enacts as follows:**

1. That this By-law be approved as the rules and procedures governing the Administrative Monetary System for the Town of LaSalle.
2. That the short title of this By-law be the “Administrative Monetary Penalty System By-law”, or “AMPS By-law”.
3. That Appendix “A” and its associated Schedules, attached hereto, form part of this By-law.
4. That By-law 8289, as amended by By-law 8466 and By-law 8830, is hereby repealed.
5. That any By-law or provision in any By-law inconsistent with this By-law is hereby repealed.
6. That this By-law shall come into force and take effect immediately upon final passing.

**Read** a first, second and third time, and finally passed this 10th day of June, 2025.

## 1. Definitions

### 1.1 In this By-law;

- a) “**Administrative Fee**” means any fee set out in Schedule “B” of this By-law;
- b) “**Administrative Penalty**” means an monetary penalty imposed for failure to comply with requirements of Designated By-laws set out in the attached Schedule “A” of this By-law;
- c) “**AMPS Administrator**” means the person(s) designated by the Director of Council Services to carry out the administrative coordination of the AMP system;
- d) “**Contravention Date**” means the date of the contravention specified on the Penalty Notice;
- e) “**Council**” shall mean the Council of the Town;
- f) “**Date of Issue**” means the Day on which an Officer issues a Penalty Notice;
- g) “**Day**” means any calendar day;
- h) “**Designated By-law**” means a By-law, or a part or provision of a By-law, that is designated for the purposes of this By-law and is listed in Schedule “A” attached to and forming part of this By-law;
- i) “**Director**” means the Director of Council Services/Clerk of the Town, or such successor office as the case may be, and includes any individual who has been authorized to temporarily act as Director during that person’s absence or a vacancy in the office;
- j) “**Hearing Non-Appearence Fee**” means an administrative fee for the failure to appear at a scheduled Hearing Review, as established by Schedule “B” of this By-law;
- k) “**Hearing Decision**” means a notice that contains a decision made by a Hearing Officer;
- l) “**Hearing Officer**” means a person appointed by Council to perform the functions of a Hearing Officer for the purposes of this By-law;
- m) “**Late Payment Fee**” means an Administrative Fee set out in Schedule “B” of this By-law, in respect of a Person’s failure to pay an Administrative Penalty within the time prescribed by this By-law;
- n) “**MTO**” means the Ontario Ministry of Transportation or any successor ministry;
- o) “**MTO Fee**” means an Administrative Fee set out in Schedule “B” of this By-law, in respect of the Town conducting a search of the records of the MTO;
- p) “**NSF Fee**” means an Administrative Fee set out in Schedule “B” of this By-law in effect at the time, in respect of a Person attempting to make a payment without sufficient funds in the corresponding account in which the Town has attempted to draw upon;
- q) “**Officer**” means a By-law Compliance Officer, Police Officer employed by the LaSalle Police Service, Ontario Provincial Police, or the Royal Canadian Mounted Police; or a Firefighter employed by LaSalle Fire Service; or any other person authorized by the Town to enforce this By-law;

- r) **“Owner”** means the Person whose name appears on the permit for the vehicle; and if the vehicle permit consists of a vehicle portion and plate portion and different Persons are named on each portion, the Person whose name appears on the plate portion;
- s) **“Penalty Notice”** means a notice issued pursuant to Section 3 or Section 4 of this By-law;
- t) **“Penalty Notice Number”** means the unique reference number specified on the Penalty Notice;
- u) **“Person”** means an individual; or a sole proprietorship, corporation, partnership, limited partnership, firm partnership, or association to whom a Penalty Notice has been issued, or an authorized representative;
- v) **“Review by Hearing Officer”** and **“Hearing Review”** and **“Hearing”** means the review of a Screening Decision pursuant to the *Regulation* and as set out in Section 7 of this By-law;
- w) **“Review by Screening Officer”** and **“Screening Review”** and **“Screening”** means the review of an Administrative Penalty made pursuant to the Regulation and as set out in Section 6 of this By-law;
- x) **“Screening Decision”** means a notice containing the decision of a Screening Officer, issued in accordance with Section 6.11 of this By-law;
- y) **“Screening Non-Appearance Fee”** means an Administrative Fee established by Council and set out in Schedule “B” of this By-law, in respect of a Person’s failure to appear at the time and place scheduled for a Screening Review;
- z) **“Screening Officer”** means a person who is appointed by Council to perform the functions of a Screening Officer;
- aa) **“Tax Roll Address”** means the mailing address and contact information for the owner of property that appears in the Town’s municipal tax assessment records;
- bb) **“Tax Roll Number”** means the 19-digit number assigned by the Assessment Commissioner to an assessable property for identification purposes;
- cc) **“Town”** means the Corporation of the Town of LaSalle;

## 2. General Application of this By-law

- 2.1 This By-law applies to, and only to, a Designated By-law as set out in Schedule “A”.
- 2.2 Subject to Sections 3, 4, 6 and 7, each Person who contravenes a provision of a Designated By-law shall, if issued a Penalty Notice, be liable to pay the Town an Administrative Penalty in the amount specified by the Designated By-law and as set out in the respective Schedules of this By-law, for each Day or part of the Day on which the contravention occurs.
- 2.3 The *Provincial Offences Act*, R.S.O. 1990, c.P.33, as amended, shall continue to apply to contraventions of a Designated By-law, except that no Person that is required to pay an Administrative Penalty under this By-law in respect of a contravention of a Designated By-law shall be charged with an offence in respect of the same contravention under the *Provincial Offences Act*.

### **3. Penalty Notice – Parking, Standing, or Stopping Violations**

- 3.1. An Officer who has reason to believe that a vehicle has been left parked, standing, or stopped in contravention of any Designated By-law, may issue a Penalty Notice as soon as reasonably practicable.
- 3.2. Every Person who is the Owner of a vehicle in contravention of a Designated By-law shall, upon the issuance of a Penalty Notice, be liable to pay to the Town, an Administrative Penalty in the amount specified in Schedule “C” of this By-law.
- 3.3. When the contravention is continuous, each Day the contravention continues shall constitute a new and separate contravention for which a Penalty Notice may be issued.
- 3.4. A Penalty Notice may include information an Officer deems necessary such as:
  - a) the vehicle licence plate number or vehicle identification number;
  - b) the make and colour of the vehicle, and Province of the licence plate and licence plate expiry date;
  - c) the Contravention Date;
  - d) Date of Issue
  - e) time of Penalty;
  - f) a Penalty Notice Number;
  - g) the date on which the Administrative Penalty is due and payable;
  - h) the identification number and signature of the Officer;
  - i) the short form wording describing the contravention as listed in Schedule “C” of this By-law or other particulars reasonably sufficient to indicate the contravention and the associated Administrative Penalty amount;
  - j) information respecting the process by which the Person may exercise their right to a Screening Review of the Administrative Penalty; and,
  - k) a statement advising that an unpaid Administrative Penalty, including any applicable Administrative Fee(s) and applicable MTO Fee(s), will constitute a debt of the Person to the Town unless cancelled due to a Screening Review or Hearing Review.

### **4. Penalty Notice – Other Violations**

- 4.1. An Officer who has reason to believe that a Person has contravened any provision in a Designated By-law may issue a Penalty Notice addressed to the Person, as soon as is reasonably practicable.
- 4.2. Every Person who is believed to have contravened a Designated By-law shall, upon the issuance of a Penalty Notice, be liable to pay to the Town, an Administrative Penalty in the amount specified in the corresponding Schedule of this By-law.
- 4.3. When the contravention is continuous, each Day the contravention continues shall constitute a new and separate contravention for which a Penalty Notice may be issued.

4.4 Penalty Notice may include information an Officer deems necessary such as:

- a) Date of Issue
- b) Contravention Date;
- c) a Penalty Notice Number;
- d) the date on which the Administrative Penalty is due and payable;
- e) the identification number and signature of the Officer;
- f) the first name and last name of the Person;
- g) the address/location on or near which the contravention happened;
- h) the Tax Roll Number, if readily available to the Officer;
- i) the short form wording describing the contravention as listed in the corresponding Schedule of this By-law or other particulars reasonably sufficient to indicate the contravention and the associated Administrative Penalty amount;
- j) information respecting the process by which the Person may exercise their right to a Screening Review of the Administrative Penalty; and,
- k) a statement advising that an unpaid Administrative Penalty, including any applicable Administrative Fee(s) will constitute a debt of the Person to the Town unless cancelled due to a Screening Review or Hearing Review.

**5. Service of Documents and Submitting Requests**

5.1 The Town may serve any document, notice or decision, including a Penalty Notice issued pursuant to this By-law by using one (1) or more of the following methods of service:

| Regular/Registered Mail to the Tax Roll Address | Date of Mailing          | Five (5) Days After Date of Mailing |

5.2 A Person’s last known address, facsimile number and e-mail address, if it was not supplied to the Officer(s), may be found in the Town’s existing records.

5.3 If any document, notice or decision, including a Penalty Notice, has been served on a Person under this By-law by way of a Person’s last known address, email or fax, there is a presumption that the notice, decision, or Penalty Notice, has been delivered to the Person.

- 5.4 In addition to the methods of service for documents provided for under Subsection 5.1, an Officer may issue a Penalty Notice for a contravention of a Designated By-law respecting the parking, standing or stopping of vehicles by:
- a) affixing the Penalty Notice to the vehicle in a conspicuous manner; or,
  - b) hand-delivering it to the person who has care or control of the vehicle, at the time of the contravention.
- 5.5 In addition to the methods of service for documents provided for in Subsection 5.1, an Officer may issue any Penalty Notice for a contravention of any Designated By-law to a Person who is believed to have care and control of a property by sending a copy of the same to by regular mail to the Tax Roll Address.
- 5.6 Any notice or document to be given to the Town in respect of this By-law shall be in writing and delivered to the Town in person, by mail, or via email.

## **6. Screening Reviews**

- 6.1 A Person who is issued a Penalty Notice may request that the Administrative Penalty be reviewed by a Screening Officer and shall do so within fifteen (15) days of the Date of Issue as noted on the Penalty Notice by submitting a request:
- a) electronically;
  - b) in person at the LaSalle Civic Centre, during regular business hours;
  - c) via mail to the LaSalle Civic Centre or,
  - d) via telephone, by calling the LaSalle Civic Centre during regular business hours, and speaking with an AMPS Administrator.
- 6.2 A Person shall specify, in their Request for a Screening Review, the format of their Screening Review (i.e. telephone, in-person, electronic, written submissions only).
- 6.3 If a Person does not request a Screening Review within the time limit set out in Section 6.1, a Person may request that the Screening Officer extend the time to request a Screening Review to a date no later than thirty (30) days after the Date of Issue noted on the Penalty Notice by submitting their request:
- a) electronically;
  - b) in-person at the LaSalle Civic Centre, during regular business hours; or,
  - c) via telephone, by calling the LaSalle Civic Centre during regular business hours and speaking with an AMPS Administrator.
- 6.4 A Request for a Review by a Screening Officer shall include the contact information of the Person, the Penalty Notice Number and particulars for the reason to which the request is being made. Requests that fail to include such information may be dismissed at the discretion of the Screening Officer.
- 6.5 Upon receipt of a Request for an Extension of Time for a Screening Review, the Screening Officer may only grant such a request where the Person demonstrates, on a balance of probabilities, the existence of mitigating or extenuating circumstances that warrant the extension of time.

- 6.6 A Person's right to request an extension of time for a Screening Review expires if it has not been exercised within thirty (30) days of the Date of Issue at which time:
- a) the Person shall be deemed to have waived the right to request a Screening Review or an extension request;
  - b) the Administrative Penalty, including any Administrative Fee(s) shall be deemed to be affirmed on the 16th day after the Date of Issue; and,
  - c) the Administrative Penalty shall not be subject to any further review.
- 6.7 If a Screening Review is granted in accordance with Subsections 6.1, 6.3 and/or 6.4, the AMPS Administrator shall provide a notice of the Screening Review to the Person in accordance with Section 5 of this By-law.
- 6.8 On review of the Administrative Penalty, the Screening Officer may decide to:
- a) affirm the Administrative Penalty and Administrative Fee(s);
  - b) cancel the Administrative Penalty and Administrative Fee(s);
  - c) vary the Administrative Penalty and Administrative Fee(s); or
  - d) extend the time for payment of the Administrative Penalty and Administrative Fee(s).
- 6.9 For the purposes of Section 6.8, a Screening Officer shall have the ability to vary the monetary amount or time for payment of the Administrative Penalty and Administrative Fee(s), when:
- a) the Person establishes, on a balance of probabilities, that the contravention as alleged on the Penalty Notice did not occur;
  - b) the Person establishes an existence of a mitigating or extenuating circumstance; or
  - c) the Person establishes that cancelling or varying the monetary fees or extending the time for payment of the monetary fees of an Administrative Penalty, is necessary to relieve any potential financial hardship.
- 6.10 Where a Person fails to attend the time and place scheduled for a Screening Review:
- a) the Person shall be deemed to have abandoned the request for the Screening Review of the Administrative Penalty and Administrative Fee(s);
  - b) the Administrative Penalty and Administrative Fee(s) shall be deemed to be affirmed;
  - c) the Administrative Penalty and Administrative Fee(s) shall not be subject to any further review by a Hearing Officer or Court; and,
  - d) the Person shall pay to the Town a Screening Non-Appearance Fee as set out in Schedule "B".
- 6.11 After a Screening Review has concluded, the Screening Officer shall prepare a written Screening Decision in consultation with the Screening Officer, to be delivered to the Person, in accordance with Section 5 of this By-law.

- 6.12 After receipt of a Screening Decision, the Person shall have fifteen (15) Days to request a Hearing Review by mail.
- 6.13 In the event the Screening Officer upholds a fee in their Screening Decision, the Person has fifteen (15) Days to pay the Administrative Penalty and Administrative Fee(s) to the Town or as otherwise determined by the Screening Officer.

## **7. Hearing Reviews**

- 7.1 A Person who is not satisfied with the Screening Decision may request that the Screening Decision be reviewed by a Hearing Officer and shall do so within fifteen (15) days of receiving the Screening Decision by submitting a request:
- a) electronically;
  - b) in person at the LaSalle Civic Centre, during regular business hours;
  - c) via mail to the LaSalle Civic Centre; or
  - d) via telephone, by calling the LaSalle Civic Centre during regular business hours and speaking with an AMPS Administrator.
- 7.2 A Person shall specify, in their Request for a Hearing Review, the format of their Screening Review (i.e. telephone, in-person, electronic, written submissions only)
- 7.3 A Person's right to request an extension for a Hearing Review expires if it has not been exercised within thirty (30) days of the Screening Decision at which time:
- a) the Person shall be deemed to have waived the right to request a Hearing Review or an extension request;
  - b) the Administrative Penalty, including any Administrative Fee(s) shall be deemed to be affirmed on the sixteenth (16th) day after the Date of Issue; and,
  - c) the Administrative Penalty and Administrative Fee(s) shall not be subject to any further review.
- 7.4 A Request for a Review by a Hearing Officer shall include the contact information of the Person, the Penalty Notice Number and particulars for the reason to which the request is being made. Requests that fail to include such information may be dismissed at the discretion of the Hearing Officer.
- 7.5 Upon receipt of a Request for an Extension of Time for a Hearing Review, the Hearing Officer may grant such a request where the Person demonstrates, on a balance of probabilities, the existence of mitigating or extenuating circumstances that warrant the extension of time.
- 7.6 If a Hearing Review is granted, the AMPS Administrator shall provide notice of the Hearing Review to the Person in accordance with Section 5 of this By-law.
- 7.7 Where a Person fails to attend the time and place scheduled for a Hearing Review:
- a) the Person shall be deemed to have abandoned the Request for a Hearing Review of the Screening Decision;
  - b) the Screening Decision, the Administrative Penalty and Administrative Fee(s) as it may have been affected by the Screening

Decision, shall be deemed to be confirmed, and shall not be subject to any further review by a Court or otherwise; and,

- c) the Person shall pay to the Town a Hearing Non-Appearance Fee as set out in Schedule “B” of this By-law.

7.9 A Hearing Officer may dismiss a Request for a Hearing Review without holding a Hearing, if, in their professional opinion:

- a) the request is frivolous, vexatious, or is requested in bad faith; or
- b) the request is related to matters that are outside the jurisdiction of the Hearing Officer.

7.10 On review of the Screening Decision, the Hearing Officer may decide to:

- a) uphold the Screening Decision;
- b) cancel the Administrative Penalty and Administrative Fee(s);
- c) reduce the Administrative Penalty and any Administrative Fee(s); or,
- d) extend the time for payment of the Administrative Penalty and any Administrative Fee(s).

7.11 For the purposes of Subsection 7.10, a Hearing Officer shall only cancel or reduce the Administrative Penalty, or extend the time for payment of the Administrative Penalty, including any Administrative Fee(s) when:

- a) the Person establishes, on a balance of probabilities, that the contravention as alleged on the Penalty Notice did not occur;
- b) the Person establishes an existence of a mitigating or extenuating circumstance; or,
- c) the Person establishes that cancelling or varying the monetary fee or extending time for payment of the monetary fee of the Administrative Penalty is necessary to relieve any potential financial hardship.

7.12 A Hearing Officer shall not make any decision respecting a review of a Screening Decision unless the Hearing Officer has given the Person and the Screening Officer and/or Officer an opportunity to be heard at the time and place scheduled for the Hearing Review.

7.13 All Hearing Reviews shall be conducted in accordance with the *Statutory Powers and Procedures Act, 1990*, as amended.

7.14 After a Hearing Review has concluded, a Hearing Decision will be prepared and deliver to the Person in accordance with section 5 of this By-law.

7.15 In the event the Hearing Officer upholds a fee in their Hearing Decision, the Person has fifteen (15) Days to pay the Administrative Penalty and Administrative Fee(s) to the Town or as otherwise determined by the Hearing Officer.

7.16 The Hearing Decision as rendered by the Hearing Officer is final.

## **8. General – Screening and Hearing Reviews**

8.1 A Screening Officer and Hearing Officer has no authority to consider questions relating to the validity of statute, regulation, or by-law, or the constitutional applicability or operability of any statute, regulation, or by-law.

- 8.2 In the interest of both the Person and the Town, Screening Reviews and Hearing Reviews shall be closed to the public to avoid the unintentional disclosure of matters potentially related to public safety and security, and sensitive financial or personal details.
- 8.3 No Person shall take or attempt to take photographs, video or voice recordings or other recordings capable of producing video or aural representations by electronic means or otherwise during any Screening Review or Hearing Review.
- 8.4 A Person may appoint an authorized representative to communicate with the Town on their behalf and/or to represent them at a Screening Review and/or Hearing Review by completing a form electronically or in person at the Civic Centre.
- 8.5 A Person may be accompanied to a Screening Review or Hearing Review by an interpreter, as arranged by and for the Person, at the sole expense of the Person.
- 8.6 A Person may supply any supporting documents they believe will support the particulars of their review to the AMPS Administrator prior to the Screening Review or Hearing Review, or the Person may provide the documents to the Screening Office and/or Hearing Officer at the review.
- 8.7 A Screening Officer or Hearing Officer may admit as supporting documents any oral or written statements from an Officer(s) or Town employee, or copies of documents pertaining to the contravention such as photographs for the review.
- 8.8 A Person may submit a "Request for Disclosure" of certain documents related to the original Penalty Notice, in the care and control of the Town as specified and in accordance with the Town's Routine Disclosure and Active Dissemination Policy, in effect at the time.
- 8.9 Screening Officers and Hearing Officers reserve the right to end a Screening Review or Hearing Review, if, in their professional opinion, the behaviour of the Person is such that the proceeding has ceased to be mutually beneficial or productive.

## **9. Prohibited Communication and Undue Influence**

- 9.1 No individual shall attempt, directly or indirectly, to communicate with or influence a Screening Officer or a Hearing Officer, with respect to the determination of an issue that is before or is pending review by a Screening Officer or Hearing Officer, except the Person.
- 9.2 Nothing prevents a Screening Officer or Hearing Officer from seeking or receiving legal advice from an external law professional not employed by the Town.

## **10. General Administration of this By-law**

- 10.1 The Director, or their designate, shall administer this By-law and establish any practices, policies, procedures, forms and notices necessary to implement this By-law, and may amend such practices, policies, procedures, forms and notices from time to time as the Director or their designate deems necessary, without amendment to this By-law.
- 10.2 Complaints and comments respecting the administration of this By-law may be submitted to the Director in writing by personal delivery during regular business hours or delivery by mail addressed to the Director. Such complaints or comments may be taken into consideration for potential adjustments or improvements to the Town's AMP system.

## **11. Financial Administration**

- 11.1 The Administrative Penalty is due and payable beginning on the Date of Issue and within fifteen (15) Days of the Date of Issue
- 11.2 A Person who does not pay an Administrative Penalty with fifteen (15) Days of the Date of Issue shall pay to the Town a Late Payment Fee and any other applicable Administrative Fee(s).
- 11.3 If an Administrative Penalty is cancelled, any Administrative Fee(s) are also cancelled.
- 11.4 Where a Person has paid an Administrative Penalty that is then cancelled or reduced pursuant to this By-law, the Town shall refund the amount cancelled or reduced including any Administrative Fee(s) imposed.
- 11.5 Officers, Screening Officers and Hearing Officers are prohibited from accepting payment for any and all fees forming part of this By-law.

## **12. Non-Payment**

- 12.1 An Administrative Penalty, including any Administrative Fee(s), that is affirmed or reduced, or in respect of which the time for payment has been extended, remaining unpaid after the date when it is due and payable, constitutes a debt of the Person to the Town.
- 12.2 The Town may notify the MTO of any default of an Administrative Penalty issued pursuant to Section 3 of this By-law, and any applicable Administrative Fee(s) or Late Payment Fee(s), which are not paid within thirty (30) Days after becoming due and payable. The MTO shall not validate the vehicle permit of the Person named in the notice of default nor issue a new vehicle permit until the Administrative Penalty and any applicable fees are paid to the MTO.
- 12.3 Where the Town notifies the MTO of a default under this By-law, the Person shall pay any applicable administrative fee(s) imposed by the MTO.
- 12.4 If an Administrative Penalty issued pursuant to Section 4 of this By-law, and any applicable Administrative Fee(s) or Late Payment Fee(s), are not paid to the Town within thirty (30) Days after becoming due and payable, it shall be deemed a debt to the Town and may be collected in the same manner as taxes in accordance with section 434.2 of the *Municipal Act*, as amended.
- 12.5 Where a Person makes payments to the Town for any Administrative Penalty, Administrative Fee(s) or Late Payment Fee(s) for which the Town is notified that there is insufficient funds available, the Person shall pay to the Town the NSF Fee set out in Schedule "B" of this By-law.

## **13. Order to Restrain**

- 13.1 In accordance with sections 431 and 440 of the *Municipal Act* the Town may apply to a court of competent jurisdiction for orders to prohibit or restrain the contravention or continued contravention of this By-law. These remedies may be sought in addition to any remedy or Administrative Penalty imposed under this By-law.
- 13.2 Nothing in this By-law shall limit the Town's right to enforce a Designated By-law by any other and all legal means.

#### **14. Severability**

- 14.1 Should any provision, or any part of a provision of this By-law be declared as invalid, or to be of no force and effect, by a court of competent jurisdiction, it is the intent of the Council that such a provision, or any part of a provision, shall be severed from this By-law, and every other provision of this By-law shall be applied and enforced in accordance with its terms to the extent possible according to the law.

#### **15. Interpretation**

- 15.1 The provisions in Part V1 of the *Legislation Act, 2006*, Chapter 21, Schedule F, as amended, shall apply to this By-law.
- 15.2 Where words and phrases used in this By-law as defined in *the Highway Traffic Act, R.S.O, 1990*, c. H.8 (the "*Highway Traffic Act*"), but not defined in the By-law, the definitions in the Highway Traffic Act shall apply to such words and phrases.

### **Schedule “A” – Designated By-laws**

- b) Animal Control By-law 8705, being “A By-law to Regulate, Licence, and Control Animals within the Town of LaSalle.”
- c) Clean Yards By-law 8797, being “A By-law respecting the maintenance of property within the Town of LaSalle.”
- d) Collection of Garbage By-law 8601, being “A By-law to establish and maintain a system for the collection and disposal of Waste in the Town of LaSalle.”
- e) Fence By-law 8946, being “A By-law to regulate Fences, Swimming Pool Enclosures, Hydro-Massage Pools, and Outdoor Swimming Pools on Private Property within the Town of LaSalle.”
- f) Fireworks By-law 8013, being “A By-law to Regulate the Sale and Discharge of Fireworks within the Town of LaSalle.”
- g) Noise By-law 8706, being “A By-law to Regulate Noise Control within the Town of LaSalle.”
- h) Obstruction of Highways and Bridges By-law 6197, being “A By-law to prohibit the obstructing, encumbering, injuring, or fouling of highways or bridges within the Town of LaSalle.”
- i) Outdoor Illumination By-law 8707, being “A By-law to Regulate Outdoor Illumination within the Town of LaSalle.”
- j) Portable Signs By-law 7375, being “A By-law to Prohibit and/or Regulate Portable Outdoor Signs within the Town of LaSalle.”
- k) Restricting Public Use of Unopen Road Allowances By-law 6807, being “A By-law to restrict the public’s use of unopened road allowances, highways, streets, alleys, and lanes in the Town of LaSalle.”
- l) Setting of Fires By-law 7170, being “A By-law Restricting the Setting of Fires within the Town of LaSalle.”
- m) Sign By-law 6407, being “A By-law to prohibit and/or regulate advertising devices, including signs, within the Town of LaSalle.”
- n) Site Alteration/Dumping of Fill By-law 7080, being “A By-law to prohibit and/or regulate the placing or dumping of fill, the alteration of grades and the removal of topsoil from land within the Town of LaSalle.”
